## The Legacy Gift

William H. and Alice T. Lanning established a hospital and a school for nurses in loving memory of their only child, Mary. She died unexpectedly, on Jan. 15, 1910, while home on Christmas break from Smith College.

Her parents announced the next day that they would build the finest possible hospital in her memory. After years of research in the United States and Europe, they worked with architects and engineers to create a state-of-the-art hospital that opened Jan. 21, 1915.

## 5 Common Excuses for Not Having a Will

It's easy to get caught up in the following excuses for not making a will. However, you owe it to yourself and your family to spend a few hours ensuring that your assets will be divided as you intend after your lifetime. Here are five excuses not to make a will—and reasons why you should anyway.

**1 “It’s too complicated.”** The process of putting together a will is actually quite simple. Just assemble a list of your assets, decide whom you want to receive them and find an attorney who specializes in estate planning.

**2 “It’s too expensive.”** Drafting a will, for average-size estates, can usually be handled with one or two meetings with an attorney. This cost is small compared to the angst that not having a will may cause your loved ones.

**3 “I don’t have an estate.”** Do you have a bank account? A car? A home? Life insurance? All of your possessions constitute your estate—and can be given away as you choose after your death.

**4 “The law will take care of it.”** It’s true that the state will determine who receives your assets—but only according to its own formula, which may not match your wishes. For instance, favorite causes such as Mary Lanning Healthcare will be forgotten.

**5 “I’m too young.”** Young parents should provide for the care of minor children through a will. A judge may not make the arrangements you would have wanted.
